## *Mendeleev Communications*

Dear Referee

You are invited to act as a referee for the enclosed manuscript, which has been submitted for publication in *Mendeleev Communications*, the journal of the Russian Academy of Sciences, launched jointly by the Academy of Sciences of the USSR and the Royal Society of Chemistry (United Kingdom) in 1991. Starting from 1st January 2007, Elsevier is the new publishing partner of *Mendeleev Communications*. The journal provides a means for the rapid publication of preliminary accounts of important new results in chemistry, mainly from the Russian Federation.

**Speedy refereeing is essential to facilitate rapid publication. In this connection you are asked to prepare a report within two weeks since the date of receipt. If you cannot report on the manuscript by the fixed date, please return the documents as soon as possible. Alternatively, please pass it on to a colleague for assessment or suggest another referee whom we might approach. Please have your report typed if this will not cause significant delay.**

Communications accepted for publication should be **novel** and **significant** and of sufficiently **wide general appeal** or **exceptional specialist interest** that preliminary publication is justified.

You are asked to consider whether the length of the manuscript is justified and to report accordingly. Extensive spectroscopic and other supporting experimental data are not needed in the published version, but may be provided as supplementary information for the referees. Only in exceptional cases should communications exceed two printed pages in length (*ca.* 1000–1500 words of main text; four to five A4 pages of typescript), and you are asked to consider particularly critically manuscripts longer than this.
